8.1 Training

WA: WA's first event of the year will be a st georges day event run inline with the nYP. However they are concerned about staffing and finding people to run events.

QLD: 2 weeks ago a venturer and rover event (Urban Challenge) was run which made the QLD chief very impressed. QLD has awarded 4 BPSA since the NRC conference.

SA: Units have brought up a few issues from last year and SA Rovers are looking at solving them.

NSW: New exec for the upcoming year has been voted upon, congrats to those incoming members! the NSW BRC conference will contain workshops that include: Election reform, Redoing the strategic plan and constitutional changes

QLD: New training officer and finance officer has been appointed, congrats! Position cycle is June to june to come in line with the branch ARP. Some region reps positions have not been filled and it creates some issue amongst regions

WA: WA has appointed an NRC delegate and branch council positions gave been filled. Congrats!

Branches have the option to contact the paper author for mor clarifying questions if needed. E.hewitt opened to the floor regarding if the paper should move to an opt-in system. B.Catlin stated that the structured debate should be the default.

S.McClymont spoke that it creates equal opportunity to each branch weather or not they want to ask questions. A.Strachan proposed that paper authors could put in the paper they want it to move to a non-structured debate. J.Bond spoke that it is better to vote on it during the meeting. B.Catlin asked that the chair asked for each paper after it is seconded that if anyone wants to move to non-structed debate. Many branches agreed
